

ORDINANCE 2004-2

THE BOARD OF MANAGERS OF THE LAKE WASHINGTON SANITARY DISTRICT
ADOPTS AND ORDAINS THE FOLLOWING:

LAKE WASHINGTON SANITARY DISTRICT
FEES AND CHARGES

Subd. 1. ISSS Fees.

- a. ISSS Construction Period Permits. The following is the fee for an ISSS construction period permit authorized by Ordinance 2004-1: \$25.00.
- b. Other ISSS Permits. The following is the fee for all other ISSS permits authorized by Ordinance 2004-1: \$25.00.
- c. Payment of Fees for ISSS Permits. All fees shall be paid with the permit application. All fees for renewable ISSS permits shall be paid by March 1st of each year following the year in which the permit had been issued.

Subd. 2. Connection and Inspection Fee.

- a. Curb Stop Connections. Following construction of the Lake Washington Sanitary District Sewer System and connection of all initial users to the System, a fee of \$125.00 shall be paid before a permit may be issued permitting any connection to any curb stop or isolation valve connection to the Lake Washington Sanitary District Sewer System. The application for a permit for any such curb stop or isolation valve connection shall be accompanied by plans and drawings prepared by a qualified engineering firm and all such connections shall be supervised by such engineers as may be selected by the Board of Managers, and the cost of the same shall be paid by the applicant. Any permit issued pursuant to this subsection shall not be valid until all such costs, and permit fees are paid in full.
- b. Hot Tap Connections. Following construction of the Lake Washington Sanitary District Sewer System and connection of all initial users to the System, a fee of \$125.00 shall be paid before a permit may be issued permitting any "hot tap" or "live" connection to the Lake Washington Sanitary District Sewer System. The application for a permit for any such hot tap or live connection shall be accompanied by plans and drawings prepared by a qualified engineering firm and all such connections shall be supervised by such engineers as may be selected by the Board of Managers, and the cost of the same shall be paid by the

applicant. Any permit issued pursuant to this subsection shall not be valid until all such costs, and permit fees are paid in full.

c. Deferred Connection Fees. In addition to any other fees required under this Ordinance, the following Sewer Availability Charges shall be paid before a permit may be issued allowing any deferred connection to the Lake Washington Sanitary District Sewer System. For the purposes of this Ordinance, a deferred connection is a connection made after completion of construction of the Lake Washington Sanitary District Sewer System, and such connection was first made available to a structure in existence at the time the District System first became operational:
