

Proposed Improvements: Streets



- 36' Wide (Curb Face to Curb Face)
- Bituminous Pavement
- Concrete Curb & Gutter
- Driveway Aprons (as-needed)
- Sidewalks (Private walks only, as needed)



Proposed Improvements: Sanitary Sewer & Services



- New 8" PVC Pipe
- Concrete Manholes
- 4" Services to Property Line
- Watertight System
- City will be televising service from property line to house.



Proposed Improvements: Watermain & Services



- New 8" PVC
- Valves, Hydrants, Fittings
- Services to R/W Line



Proposed Improvements: Storm Sewer



- Extended into Project Area
- Remove Valley Gutters
- Additional Inlet Capacity
- Pipe Stub for Future Money Creek Storm Sewer




Proposed Improvements: Lamplighters Lane

LAMPLIGHTERS LANE TYPICAL SECTION






Tentative Construction Schedule




Construction Issues: Project Delays

Construction Issues: Mail Delivery

- Contractor will work with Post Office
- Temporary mailboxes
- Location will be provided in newsletter
- Remove/Reinstall



Construction Issues: Water/Sewer Services

- Services replaced to R/W line
- Remaining service will be inspected, homeowner notified if replacement is required/recommended
- Replacement from R/W to home would be homeowner's responsibility
- Temporary Water



Overview

The City of Rushford is planning for the 2019 Street and Utility Reconstruction Project within the areas highlighted in the map below.

Construction for this project is expected to begin during early May.

The City will be hosting a *Neighborhood Informational Meeting* for residents within the proposed project area on *Wednesday, April 17th, 2019* from *5:00pm to 7:00pm* at the *Rushford City Hall*. <u>A short presentation is planned</u> for 5:15pm.

During this meeting, we plan to discuss the various stages of work required, access to streets and driveways, anticipated completion dates, reestablishment of turf, and many other topics.

Project Overview

The City of Rushford is beginning to plan for the 2019 Street and Utility Reconstruction Project within the following areas:

- E Grove Street (Walnut Street to Money Creek Street)
- N Burr Oak Street (E Grove Street to Circle Drive)
- Walnut Street (E Grove Street to E Rushford Avenue)
- Lamplighters Lane (Street improvements only)

Improvements will include complete replacement of bituminous pavement, curb and gutter, watermain and services, and sanitary sewer mains and services. Underground storm sewer will also be extended into the project area. The estimated cost of the proposed improvements is \$1.825 Million. A portion of the project costs will be assessed to adjacent properties in accordance with Chapter 429 of the Minnesota Statutes.
