# **Hwy 30 Construction Update**

Utility work will continue within Phase 2 for the next several weeks. Sanitary sewer will be installed this week. After this crews will be connecting properties between Stevens and Bluffview to temporary water.

Within Phase 1, pavement is expected early during the week of August 8<sup>th</sup>. Sidewalk work will start later in the week.

## **Temporary Water & Sewer Locating**

Houses between Bluffview Road and Stevens Avenue will be switched to temporary water service in the next few days. The contractor will be contacting you and may need to access your home. You may also be asked for access to your basement to allow crews to locate sewer lines.

## **Concrete Work**

Over the next two weeks, the contractor will be placing curb, driveway and sidewalk concrete. Prior to pours the contractor will be using stakes, stringlines and forms. It is very important that these items be undisturbed until work is complete. If you need assistance navigating around these devices, please contact us.

After concrete is placed, wet concrete can sometimes be indistinguishable from dry concrete. As a best practice, <u>please do not walk on any concrete that you are seeing for the first time</u>.

You may walk on concrete 24 hours after placement. Do not drive on new concrete for 7 days after placement. Any questions can be directed to the contact provided below.

## Vehicle Access, Mailboxes, Garbage

No substantial changes in vehicle access, mailbox locations or garbage pickup is expected during the next two weeks.
